The installer must connect the power distribution unit to an electrical supply that has a protective earth conductor.

For pluggable equipment, the socket outlet shall be installed near the equipment and shall be easily accessible

For permanently connected equipment, a readily accessible disconnect device shall be incorporated external to the equipment.


Rack PDUs must be protected by a branch circuit protective device rated at the maximum rating of the product specified on the product rating label.

To avoid risk of overload, do not plug additional multiple outlet power distribution devices into the rack PDU socket outlets.

Plug Connection Procedure


These products are intended to be connected by the customer and must be installed by a competent person in line with local and national regulations.



• Hard Wiring Procedure

These products are intended to be hardwired by the customer and must be installed by a competent person in line with local and national regulations.

To install the power cable, remove the securing screws on the removable user panel and connect the conductors to the rack PDU terminals. Conductors shall be connected in line with the terminal markings provided. Ensure that the cover is replaced and secure before commissioning.




Product Mounting

This product contains an external M5 earthing stud which can be used for supplementary earth bonding to the rack metalwork.


Tool-less Mounting button

The product is intended to be installed using the tool-less mounting buttons, buttons locate in the fixing holes provided.




Bracket Mounting button

The product is intended to be installed using via the fixing brackets found at either end of the rack PDU with accessories provided.




 Horizontal 19" Mounting of SmartZone Zero-RU Inline Meters (Duel Link Boxes)



This product is intended to be installed using the racks RU mountings via the brackets found at either end of the rack PDU with fixing accessories provided.

SmartZone 1RU Inline Meters (IQ Adaptors)

This product is intended to be installed to the racks frame via the fixing plate mounting holes found at either end of the PDU using fixing accessories provided. Fixing plate can be adjusted for mounting as per below.
